If you have diabetes, you may need diabetic supplies, such as a blood glucose monitor or blood glucose test strips. Your Horizon Blue Cross Blue Shield of New Jersey medical plan's durable medical equipment (DME) benefit can help you get them.

To obtain diabetic supplies, first obtain a prescription from your doctor for the supplies you need. Depending on your plan, a copayment, coinsurance and/or deductible may apply.

## If You Live in New Jersey

The Horizon Care@Home program will coordinate the delivery of your diabetic supplies from a participating Horizon Care@Home provider. To find a provider, visit the *Online Doctor & Hospital Finder* at **HorizonBlue.com/doctorfinder**. Select *Other Healthcare Services* from the *What are you looking for?* dropdown menu. Choose "Durable Medical Equipment" from the *Service Type* dropdown menu, select your plan and click *Search*.

## If You Live Outside New Jersey
